- Coastal Restoration Fund: DFO agreed to some flexibility, so we decided to carry forward \$66,000 to next year.
- Canada's Summer Jobs is also offering more flexibility.
- Pipe for Tim's Creek culvert project is being ordered.
- Sarah applied to the COVID-19 Workspace Adaption Assistance Fund to cover PPE costs, etc.
- The Board agreed to promote one of the field crew to the position of Assistant Field Supervisor, with a raise of up to \$1.00/hour (going forward).
- We are still trying to work the kinks out of our paperless system.
- The field crew has been doing a lot of brush-matting and stream clearing.
- Staff are also doing crop mapping.

## 10. Personal devices for WRTBWA work

- Sarah bought all crew members waterproof protective cases for their phones.
