Main expenses: wages, mileage, utilities, rent, remittance, office supplies, water testing.

**Main revenue**: Canada Summer Jobs, Wildlife Conservation Fund, College and Institutes Canada Jobs, PEI Brewing Co waterfall fund.

#### 4. Field Committee's Report

John reported for the committee. He was pleased with the Field Report that Hilary prepared and a discussion followed. The report shows just how vast the watershed area is, though sometimes it is difficult to identify the locations of small maps that were included. Recommend simplifying some of the many maps, or adding an overview map to the report. The board will take a couple of weeks to study the report and give feedback on the recommendations and data it contains. He congratulated Hilary on her excellent work.

- Charitable Status: Sarah reviewed the Charitable Status designation and the benefit to the organization. She proposed the setup of a CanadaHelps.org account linked to our website for online donations. It was moved by Scott and seconded by Cathy that WRTBWA use CanadaHelps.org. Motion carried.
- Accounting Program: It was moved by Scott and seconded by Lowell that we purchase Sage Simply Accounting software for Sarah's use. Motion carried.
- Watershed Boundary Lines: A committee composed of John, George, J.P, and Cathy met to discuss the ongoing process initiated by Friends of Covehead and Brackley Bay (FCBB) over the boundary line between the two watersheds. The committee drafted a letter for the board's approval. This letter will be our response to a request from Kate MacQuarrie, the director of Forests, Fish and Wildlife for the province, for information on this issue. A final version of the letter was approved following a motion from Lowell, seconded by Scott. Motion carried.
- Office Sharing: Following a request from an organization to share our office space, the Board declined the request.
- Snowshoe Event: Annual event planned for Saturday, February 11, 2017 with a storm date of February 18, 2017.
