#### Coordinator's Report – Sarah Wheatley reported (see report)

- Sarah's main priorities in March were grant writing and writing the final report. This continued into April.
- Working on changes to the work plan for Wildlife Conservation Fund.
- Sarah had a Zoom meeting with Gwen Vessey and discussed possible agricultural project demonstration sites.
- Sarah is currently in the process of confirming staffing plans.

#### 10. Savage Harbour Watershed

At February's Board meeting, we said we would write a letter to Mary Finch voicing our concerns about the lack of public
consultation in changes to the Savage Harbour Watershed. Mary received our letter, responded, and brought it to the

attention of her executive committee of the Watershed Alliance. We also sent a short letter to Kate McQuarrie but have not received any response.

## 11. COVID-19 Impacted Activities

- Audit: Books have not been closed for the year. Still tying up loose ends. Accountant working from home 4 days a week. Sarah and Lowell normally go into the office, but this can be done by email this year.
- AGM: Board agreed to postpone the AGM until September. We will revisit this decision next month, along with the newsletter conversation. Current Board members will stay on until the AGM. Board discussed possible new members and our plans to reach out to them.
- Lady Slipper Walk: We should know more about the status of our walk by May's meeting.
- **Field Season:** According to the Province, we are not yet allowed to do any field work. When field work resumes, we may need to do some form of self-screening (e.g., take everyone's temperature before starting a shift). We may also need to budget for extra mileage so employees can take their own vehicles to the work site. If one crew member becomes infected with COVID-19, the entire crew will be expected to self-isolate for 14 days. Sarah will continue to seek guidance in this area.

#### 12. Tim's Creek Culvert Project with TIE

- Sarah received a new pipe quote via TIE for approx. \$64,000, incl. tax.
- This is the same pipe Campbell's Concrete quoted on, but it will be approx. \$8,000 less if we buy it through TIE.
- Sarah is recommending that we buy the pipe and have Transportation install it.
- TIE thinks this project is going to proceed as planned.
- Our proposed payment plan is to write a \$10,000 cheque now and pay the balance upon delivery.
- JP moved to proceed with the purchase of the pipe through TIE from Soleno Inc. at the quoted price. Dwayne seconded. All were in favour. None opposed. Motion carried.
