

### 1. Clare called the meeting to order at 7:03 PM

### 2. Started with remarks from the Chair of the Board, Clare Martin

### Independent Auditor's Report

To the Members of Winter River-Tracadie Bay Watershed Association Inc.

### Opinion

We have audited the financial statement of Winter River-Tracadie Bay Watershed Association Inc. (the "Association"), which comprises the statement of cash receipts and disbursements for the year ended March 31, 2020, and notes to the financial statement, including a summary of significant accounting policies.

In our opinion, the accompanying financial statement presents fairly, in all material respects, the cash receipts and disbursements of the Association for the year ended March 31, 2020 in accordance with the cash receipts and disbursements basis of accounting described in Note 1.

### Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statement section of our report. We are independent of the Association in accordance with the ethical requirements that are relevant to our audit of the financial statement in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### Emphasis of Matter - Basis of Accounting

We draw attention to Note 1 to the financial statement, which describes the basis of accounting. The financial statement is prepared to provide information to the organization. As a result, the financial statement may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

### 5. Report from the Chair

- Clare Martin took the microphone at 7:25 pm.
- As in the past our Watershed continues to support the residents of the Watershed.
- The Watershed Management Plan created by the Board of Directors guides the work of the Board which is carried out by staff. The focus of the Plan is to sustainably use the watershed's resources.
- Actions guided by the Management Plan in 2019 to protect the quantity of ground water in the Watershed include:
  - Sept 2019 Organized a meeting with MLAs from all parties, and the Mayor of Charlottetown
  - Oct 2019 Attended Public meeting in Charlottetown as well as a private meeting with the Deputy Minister of the Environment regarding the proposed Water Withdrawal Regulations associated with the new Water Act.
  - Nov 2019 Met with City and Province as part of Winter River Water Committee
- Actions guided by the Management Plan in 2019 focusing on land based activities that impact surface and ground water include:
  - Remediation of soil erosion situation with input from all parties. Health of stream in that area has improved.
  - 3 follow-up meetings help with multiple stakeholder groups
- Description of information available on the Association's Website
- Clare concluded by thanking the members of the Board, the Coordinator, and staff for their hard work and dedication.

### 6. Report from the Coordinator

Sarah Wheatley took the microphone at 7:30 pm.

- Sarah shared pictures of the staff from a fundraising event and the staff fun day.
- Sarah's report included a description of stream work, shoreline clean-ups, hedgerow planting, forest enhancement work, crop rotation maps, culvert surveys & repairs, community events, education days, and data collection.
- Sarah described the changes required for COVID-19.
- Sarah thanked our partners and highlighted plans for the upcoming year.









Other sites: Beaton's Creek? MacAulays's Creek?






