Events (Spring/Winter hikes etc.) will be organized by the Communications/PR committee.

Watershed Alliance – George & Sarah went to the annual meeting. It was discussed that funding has not been equitable across watershed groups, based on area. Sarah went to the Central Watershed group meeting. Want to make sure our POV is addressed.

External Relations committee will meet with the City on June 19. Funding has been approved, hope to have a cheque soon.

3. Review of past year and a look into 2015

Scott – would like to have funding information, so that each person knows how the funding applications work, where money comes and goes.

Tree planting – George tagged topographical map. Sarah has sent letters to those landowners.

By late August this year, looking at the field to see what has been done, and what we can plan for next year. John pointed out that existing trees, planted other years, need pruning & maintenance. Why are gaspereau being lifted into the pond (past the fish ladder)? Work is more meaningful if we know why things are being done.

	Scott – we need to look at things like water temps, fish ladder not working on Officer's Pond, cleaning springs, and address these things with FPT groups.
	George discussed the tree plantings – right tree for the right spot. Sarah will explain in more detail at the next meeting.
	George will ask Sarah will bring more info on staffing and funding at our next meeting.
5.	Marian White letter Should we address it or not? Ms. White did not attend the annual meeting. Cathy replied, not as part of the watershed, to Ms. White's Facebook comment. Decided that we would not address it directly.
6.	Holiday pay - Employment standards act – 4%, which represents 2 weeks holidays. Practice of paying it out every two weeks is well established. Other option is to hold 4% and pay it out at the end of the employment contract.
	Course – Sarah attended Wilderness First Aid - $^{\sim}$ \$700 cost. Moved by John that we pay 50% of the cost of the course. Seconded by Scott. Motion carried.
